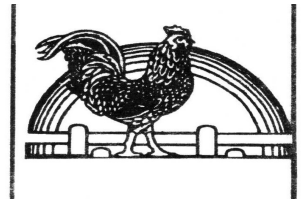

## 2012 BUSKING APPLICATION

1. Buskers are welcome at the Kamloops Farmers Market, however space is limited.
2. All entertainers must make application to the Market for a space, preferably **before** the date of performance. To make arrangements for your performance, please contact one of the people below:

3. Each market season, if space is available and application is approved, performers are allowed three appearances at no charge. Subsequent performances are subject to a fee of \$10 per day.
4. Entertainers invited by the Kamloops Regional Farmers' Market Managers or Music Co-ordinator are not charged a fee.
5. In consideration of vendors and the community, buskers are NOT permitted to use amplification devices. Placement of the buskers is at the discretion of the Market Manager. Also, buskers must rotate to another space after two hours of performing.
6. Buskers are NOT allowed to sell products at the Kamloops Farmers' Market. Those wishing to do so may apply as a home-based-business.
