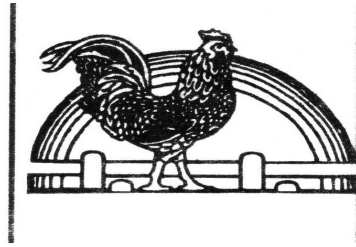

FEE SCHEDULE

Local season fees include an annual membership fee of \$2.00. Fees are set on the basis of 1/2 spaces which are approximately 10 feet wide and full spaces which are approximately 20 feet
